REGULATIONS

on the organization and conduct of international competitions in fire and rescue sport while the risks of the spread of coronavirus infection COVID-19 remain

1. General points.

The organizers of international competitions in accordance with the requirements of international competitions are responsible for compliance with the requirements of these Regulations when holding international competitions in fire and rescue sport.

The organizer of international competitions in fire and rescue sport, in accordance with the Regulations on the Competition, is obliged to notify the highest official (head of the highest executive body of state power), in whose territory the international competitions in fire and rescue sport are planned, no later than 35 days before the start of the competition, on the intention to hold the competition on time.

2. Measures aimed at preventing the spread of COVID-19 in the organization and conduct of international competitions in fire and rescue sport.

The organizer of international competitions in fire and rescue sport is obliged to:

- organize thermometry among the participants and staff entering the facility using non-contact thermometers;
- provide testing for the new coronavirus infection COVID-19 by the polymerase chain reaction (PCR) method of participants and personnel of international competitions with the results obtained before the start of the competition;
- provide conditions for hygienic treatment of hands with the use of skin antiseptics at sports facilities or in competition venues;
- oblige the participants, spectators (if any) and the attendants of the competition to use personal protective equipment, with the exception of the period of competitive and training activities (for athletes and sports judges);
- organize accommodation, meals and transport of the participants in the competition in compliance with sanitary and hygienic requirements;
- organize the work of the Commission for the admission of participants (hereinafter referred to as the Commission), taking into account the sanitary and hygienic requirements and the required time interval for receiving documents for each team, ensuring the participation of one representative from the team in the work of the Commission;
- prior to the Commission, organize a medical examination by a doctor of the competition and thermometry of the participants in the competition who arrived from different countries;

- draw up a schedule for the arrival of participants (teams) to the sports facility or to the competition venues with a time interval between participants (teams) from different countries, necessary for sequential entry, thermometry control and preparation for the competition;
- at the sports facility, exclude the sharing of dressing rooms by different teams (1 team 1 dressing room). If it is impossible to provide separate dressing rooms, draw up a training and competition schedule, taking into account the use of separate dressing rooms and the training and competition schedule, the arrival of participants (teams);
- before the opening of the sports facility and on a daily basis, carry out general cleaning of the premises and treatment of sports equipment with the use of disinfectants;
- to restrict the entry to the territory of the sports facility for persons not related to the provision of competitive and training processes;
- carry out disinfection treatment every 2 hours in changing rooms, washrooms, contact surfaces (handrails, door handles, railings, etc...).

If an elevated temperature and (or) other symptoms of ARVI are detected in the competitors, it is necessary to:

- notify the chief doctor of the competition and the representative of the team of the participating country;
- isolate a person with an elevated body temperature and (or) other symptoms of acute respiratory viral infections in a separate room and send them to a medical organization with specialized vehicles;
- to identify a possible circle of persons who have been in contact with a person with an elevated body temperature.

The organizer of international competitions in fire and rescue sport should instruct the team representatives on the need for the competitors to comply with the requirements of these Regulations, to immediately inform the team representative about any deviations in their health, and the use of personal protective equipment.

Financial expenses in the case of observation participant, for being on of observation (quarantine) competitors with the signs of the presence of the new coronavirus infection COVID-19 and persons exposed to them in the course of the competition, for the return to their homes are responsible sending organizations of the countries that sent participants to the competitions.
