On the approval of the budget for 2021, the target size of contributions and the procedure of their payment

According to paragraph 1.1, 11.5-11.8 of the Charter of Non-Profit Partnership «The International Sport Federation of Firefighters and Rescuers» Federation property is based on contributions from its members. Earmarked contributions for the financing of specific sporting events, entry and membership fees are directed to the maintenance of authorized activity and the content of the Federation. The amount of entry and annual membership fees that make up the budget of the Federation and target fees are set and approved by the Resolution of the Conference.

After hearing and discussing the report of the bids received, XXI International Conference of Non-Profit Partnership «The International Sport Federation of Firefighters and Rescuers» has decided:

- 1. To approve the budget of expenses of the Federation for the year 2021.
- 2. Allow the Director of the Executive Committee to make changes and additions to budget items during the year within 15% of the budget amount.
- 3. To approve the entry fee of a candidate country for membership of the Federation in the amount of 5000 (five thousand) US dollars.

The country which has paid the entry fee in the current year shall be exempt from paying the membership fee.

4. To approve the annual membership fee of members of the Federation in the amount of 3300 (three thousand three hundred) US dollars.

Country-organizers of the World Championships are exempt from paying the annual membership fee.

The heads of national federations, associations and other institutions that are members of the Federation provide an annual payment of membership dues to April 1 of the current year.

- 5. To approve the participation fee 2021 in amounts:
- **5.1.** At the world Championships among boys and girls 180 (one hundred eighty) US dollars per one participant of the sports delegation.
- **5.2.** At the world Championships for men and women 210 (two hundred ten) US dollars per one participant of the sports delegation.

The procedure for payment of the participation fee is established by the Regulation of conducting the Championship.
