RESOLUTION

November 13, 2022

Istanbul (Republic of Turkey)

On the approval of the budget for the year 2023, the amount of targeted contributions and the procedure for their payment

According to paragraphs 6.1.-6.7. of the Charter of International Association "The International Sport Federation of Firefighters and Rescuers", the property of the Federation is formed on the basis of membership and entrance fees, which are directed to the conduct of statutory activities and would be used for expenditure by the Executive Directorate. The participation fee intended to finance specific sporting events is received by the host country of the competition. The amounts of targeted contributions, as well as the procedure for their payment, are established and approved by the Resolution of the conference.

After hearing the report and discussing the proposals received, the XXIII International Conference of International Association "The International Sport Federation of Firefighters and Rescuers" **decided:**

1. To approve the budget of the Federation for the year 2023.

2. To approve the entry fee to the Federation in the amount of 5,000 (five thousand) US dollars.

The country that has paid the entry fee is exempt from paying the membership fee in the current year.

3. To approve the annual membership fee in the amount of 4,000 (four thousand) US dollars.

The host country of the World Championship is exempt from paying the membership fee in the current year.

The heads of national organizations, federations, associations and other structures that are members of the Federation should ensure the annual payment of membership fees by April 1 of the current year.

4. To approve the contribution for participation in 2023 in the amount of:

4.1. At the World Championships among boys and girls -210 (two hundred ten) USD per participant of the sports delegation.

4.2. At the World Championships for men and women – 280 (two hundred eighty) USD per participant of the sports delegation.

The procedure for paying the participation fee is established by the Regulations on holding the championship.
