RESOLUTION

November 12, 2022

No. 5

Istanbul (Republic of Turkey)

On the work of the Sport and Disciplinary commission for the period 2019-2022

In pursuance of the Plans of the main sporting events of the International Sport Federation of Firefighters and Rescuers for the period 2019-2022 and the resolutions of the International Conferences of the International Sport Federation of Firefighters and Rescuers, 6 world championships among men and women, 6 world championships among boys, juniors, girls and juniors were organized and held.

The Sports and Disciplinary Commission was implementing its functions in order to carry out control and disciplinary functions for the observance of sports discipline and sports ethics, the execution of regulatory documents at all World Championships from 2019 to 2022.

After hearing and discussing the report of the Chairman of the Sports and Disciplinary Commission, the XXIII International Conference of International Association "International Sport Federation of Firefighters and Rescuers" decided:

- 1. To consider the moral and ethical situation in the competition and out-of-competition periods of the World Championships from 2019 to 2022 as generally satisfactory, and the quality of execution of regulatory documents as appropriate, taking into account the following indicators:
- absence of written (oral) appeals, complaints and other statements about disciplinary violations committed by competitors during the World Championships;
- timely fulfillment of the requirements and instructions emanating from the Ground Jury, members of committees, commissions and heads of sports delegations in compliance with the principles of subordination and mutual relations in the field of sports activities;
- making constructive decisions within the framework of professional competence and qualifying sports position in the event of difficult situations and disagreements.
- 2. To assess the work of the management and coaching staff of sports delegations on the formation of sports-ethical and moral principles of the competitors, based on mutual respect, loyalty, tolerance and moral qualities of each athlete, as generally satisfactory.
- 3. Based on the results of the work made from 2019 to 2022, taking into account the existing disciplinary violations, the Sports and Disciplinary Commission recommends:
- representatives and coaches should conduct educational work with members of national teams on ethics during international competitions in fire and rescue sport.
