RESOLUTION

November 12, 2022

Istanbul (Republic of Turkey)

On the powers and composition of the governing management bodies, executive and controlling committees and commissions

In order to further implement the activities of the International Sport Federation of Firefighters and Rescuers and in compliance with points 7.1., 7.2., 7.3., 7.4., 7.5., and also in connection with the expiration of the term of office of the President of the International Sport Federation of Firefighters and Rescuers A.P.Chupriian, the XXIII International Conference of International Association "International Sport Federation of Firefighters and rescuers" decided:

- 1. To elect the President of the International Sport Federation of Firefighters and Rescuers Alexander Petrovich Chupriian for a period of four years.
- 2. To carry out the current management, organize the implementation of the decisions of the Conference, the President and the solution of other issues within its

competence, elect the Director of the Executive Directorate of the International Sport Federation of Firefighters and Rescuers Andrey Petrovich Kalinin for a period of four years.

3. For the purpose of coordinated activities, development of international cooperation and making decisions within their competence, to elect the Vice-Presidents of the International Sport Federation of Firefighters and Rescuers for a period of four years:

Republic of Austria - Prutscher Wolfgang;

Republic of Belarus - Khudaleyeu Aliaksandr;

Republic of Bulgaria - Petkov Varban;

Republic of India - Singh Amrinder;

Islamic Republic of Iran – Poustchi Khorasani Morteza;

Republic of Kazakhstan – Ilyin Yuri Viktorovich;

Republic of Cameroon - Atanga Nji Paul;

State of Qatar - Al Dehaimi Hamad Othman;

Kyrgyz Republic - Shamyrkanov Urmatbek Muslinovich;

People's Republic of China – Wei Handong;

Republic of Ivory Coast - Amankou Kassi Gabin;

Mongolia - Ariunbuyan Gombozhav;

Republic of Niger - Adamou Souley Hamadou;

Russian Federation - Kudinov Sergei Mikhailovich;

Kingdom of Saudi Arabia - Hammoud bin Suleiman Al-Faraj.;

Republic of Senegal – Mbaye Mayoro;

Slovak Republic - Nejedly Alexander;

Republic of Turkey – Albayrak Remzi;

Republic of Uzbekistan – Zuparov Sanjar Tahirovich;

Republic of Tajikistan – Umarzoda Bakhtiyor.

- 4. To control the financial and economic activities of the International Sport Federation of Firefighters and Rescuers within its competence:
- 4.1. Elect the Audit Commission (AC) of the International Sport Federation of Firefighters and Rescuers consisting of 3 people. The Chairman of the Auditing Commission is Andrienko Margarita (Republic of Belarus), members of the Commission are Larizade Peiman (Islamic Republic of Iran), Borievka Jan (Slovak Republic).
- 4.2. The members of the AC should hold elections of the President of the commission, report the results to the Executive Directorate of the International Sport Federation of Firefighters and Rescuers and organize the work for the implementation of the assigned functional responsibilities.
- 5. In order to improve the rules of fire and rescue sports competitions of the International Sport Federation of Firefighters and Rescuers, the Regulations of the competitions, elect the Chairman Klitonciks Aleksandrs (Republic of Latvia) and the members of the Sports and Technical Committee (STC) of the International Sport Federation of Firefighters and Rescuers: Bazarbayev Askar (Republic of Kazakhstan), Dudonov Iurii (Russian Federation), Wang Cai (People's Republic of China), Kalinowski Piotr (Republic of Poland), Lefner Tomaš (Czech Republic),

Nejedly Alexander (Slovak Republic), Suponenka Uladzimir (Republic of Belarus).

6. In order to coordinate, effectively interact at the international level and implement the anti-doping policy aimed at alerting and preventing the use of doping, elect the Chairman Andrienko Margarita (Republic of Belarus) and the members of the Disciplinary and Anti-Doping Committee (DAC) of the International Sport Federation of Firefighters and Rescuers: Vetukh Vladimir (Republic of Latvia), Danaev Dauren (Republic of Kazakhstan), Islamov Sardor (Republic of Uzbekistan), Kapusniak Jaroslav (Slovak Republic), Pehlivan Emin (Republic of Turkey), Zhang Cong (People's Republic of China), Ella Yolande Emeline (Republic of Cameroon).

7. In order to carry out control and disciplinary functions, to consider and resolve disciplinary issues and to ensure a high level of sports competitions, elect the Chairman Rebrova Natalia (Russian Federation) and the members of the Sports and Disciplinary Commission (SDC) of the International Sport Federation of Firefighters and Rescuers: Waldhoer Natalia (Republic of Austria), Sharipov Ismoil (Republic of Uzbekistan).

8. In order to facilitate the establishment of contacts and international cooperation with the countries of the African continent in fire and rescue sport, to empower the official representative of the International Sport Federation of Firefighters and Rescuers, Kotchofa Anicet Gabriel.
