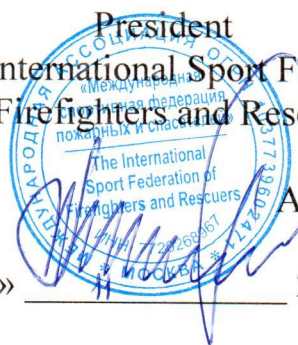

The report of the Audit Commission on the financial and economic activities of the Federation for the year 2022 is presented.


