RESOLUTION

**On the conduct and results of the World Championships
and the work of the Ground Jury in 2023**

Guided by the Charter of International Association "The International Sport Federation of Firefighters and Rescuers" pursuant to the Plan of the major sporting events of the International Sport Federation of Firefighters and Rescuers for 2023 and resolutions of the XXIII International Conference of the International Sport Federation of Firefighters and Rescuers dated November 13, 2022 No. 12 "On approval of the regulations of the World Championships in 2023" and dated November 13, 2022 No. 13 "On approval of the composition of the Ground Jury of the 2023 World Championships", according to the regulations on the competitions were organized and held:

- The XVIII World Championship among men and the IX World Championship among women in fire and rescue sport "Istanbul-2023" (Republic of Turkey);

- The XII World Championship among boys and juniors and the VIII World Championship among girls and juniors in fire and rescue sport "Saransk-2023" (Russian Federation).

The above-mentioned World Championships were attended by sports delegations from 23 countries. New records have been set in the sports disciplines of fire and rescue sport, where athletes of women's national teams and girls and juniors' national teams have achieved significant success.

Professional training and performance of judicial duties by judges of the Ground Jury of the World Championships meet the qualification requirements for judges of sports competitions of international level.

After hearing and discussing the reports on the 2023 World Championships and the work of the Ground Jury, the XXIV International Conference of International Association "The International Sport Federation of Firefighters and Rescuers" **decided:**

1. To consider the resolutions of the XXIII International Conference of the International Sport Federation of Firefighters and Rescuers on holding the 2023 World Championships at a satisfying level fulfilled.

2. To recognize the work of sports judges of the Ground Jury of the 2023 World Championships performed at a high organizational level and in accordance with the requirements of the qualification categories of sports judges.

3. The chief judge of the next World Championship shall perform duties in terms of preparing and submitting the report of the chief judge at the end of the competition, in accordance with Article 3.3.2 of the Rules of the competition in fire and rescue sport and Appendix No. 17 to the Rules.

4. The Chief Secretary of the next World Championship should perform duties regarding the preparation and submission of the record registration act at the end of the competition, in accordance with Article 3.7.1 of the Rules of competition in fire and rescue sport and Appendix No. 16 to the Rules.

5. To form the composition of the Ground Jury and judging panels of the 2024 World Championships, taking into account the increase in the number of competition teams.

6. To indicate to the countries hosting the World Championships on compliance with the Regulations of international competitions in fire and rescue sport, in terms of:

- organization of meetings of sports delegations;
- transport support;
- fire and technical equipment;
- electronic measuring equipment "Start-finish System";
- online broadcast of the World Championships;

- doping testing of participants of the World Championships;
- award ceremony and prize fund according to Regulations on competitions.
