REGULATION

on holding IX World Championship among youth and juniors and V World Championship among girls and juniors in fire-rescue (fire-applied) sport «Saratov- 2019»

1. Goals and objectives of the competitions

IX World Championship among youth and juniors and V World Championship among girls and juniors in fire-rescue (fire-applied) sport (further – Competitions) is aimed at:

- further international cooperation, development of fire and rescue sport and popularization of professions of a firefighter and rescuer among children and young people;
- attracting of young people in fire and rescue sport and participation in international competitions;
- formation of active life position, professional orientation of the younger generation, the preservation and strengthening of children's health, teenagers and youth;
- improvement of sportsmanship and physical education of young firefighters and rescuers;
- strengthening of friendly relations and exchange of experience in training young athletes;

- preparation of sports reserve for the national sports teams.

2. Organization of the competitions

The General management and organization of the competition is carried out by the International Sport Federation of Firefighters and Rescuers in cooperation with the Ministry of the Russian Federation for Affairs for Civil Defence, Emergencies and Elimination of Consequences of Natural Disasters and the government of the Saratov region.

The direct organization and conducting of competitions (preparation of the competition places, transfer of the participants from the airport to the hotel and back, medical service, provision of the sports and technical equipment, catering services and accommodation, cultural program, publicity in the mass media, etc.) is carried out by the main Department of the EMERCOM of Russia in the Saratov region, the Central sports club of the EMERCOM of Russia, the Ministry of youth policy and sports of the Saratov region, the Ministry of culture of the Saratov region, the Ministry of finance of the Saratov region, Ministry of education of the Saratov region, Ministry of transport and roads of the Saratov region, Ministry of information and press of the Saratov region.

Competitions are held in accordance with the rules of competition in fire-rescue (fire-applied) sport and the Rules of international competitions in fire-rescue sport with the additions and changes in 2018.

The fire and technical equipment (with photo), which apply in combat deployment and fire relay race, should be published on the website www.interfiresport.com not later than June 25, 2019.

The competitions are held in the combat deployment of the motor pumps of the company «ROSENBAUER FOX III» with connecting hoses STORZ.

3. Timelines and venue of the competitions

The competitions will take place: from 08 till 16 September, 2019. The venue of the competitions: city Saratov (Russian Federation).

4. Participants and conditions of admission

The competition involves teams of boys and girls of the member countries of the International Sport Federation of Firefighters and Rescuers, as well as of the countries received an invitation.

The composition of sports delegations - 31persons: head of delegation - 1, representative of team - 2, coach (boys, girls) - 2, couch-educator - 2 (boys, girls), doctor - 1, referee - 2, press - 2, interpreter - 1,

athletes - 9 people: born in 2001-2002 - 3 (junior), born in 2003 - 2004 - 3 (average group), 2005 birth - 3 (younger group);

athletes - 9 people: born in 2001 - 2002 - 3 (junior), born in 2003 - 2004 - 3 (average group), 2005 birth - 3 (younger group).

It is allowed to change of quantitative structure of delegation taking into account the declared athletes and sports personnel.

The representatives of teams need to submit to credentials committee the signed request and passport (or identity card). The athletes for competitions are not allowed without these documents. The request should be separate for men's team and women's team.

Competitions in climbing on an assault ladder, overcoming the 100-meter obstacle, combat deployment carried out on two attempts.

7. Procedure and conditions of defining the team and individual championships

Overall team championship is determined on the basis of the least amount of places, taken by teams in all the sports events. In case of equality in total places, the higher place is awarded to the team having best result in the combat deployment.

Team championship in the sports events is determined on the basis of minimum total time. In case of time equality, the teams are awarded the same place (subsequent place is not awarded).

The team, which has not total number of scores, is awarded a place after the teams having full score. In case of equality of incomplete scores, the team is awarded a place to the team having the minimum score time.

Individual championship in sports events including combat deployment is determined according to the best result from two attempts. In case of results equality – according to the best total time of two attempts, and in case of equality amounts of time two attempts – according to the best result of the first attempt, further – athletes who started earlier. In the case of equal results in the fire relay highest place is awarded to the team which started earlier.

Double event do not include in team result.

To determine winners in climbing on an assault ladder and overcoming 100-meters obstacles is held final race. The amount of athletes in final races is determined by the number of racetracks. The results of final races do not include in team result.

Final race is formed by the results of final races as follows: 3, 1, 2 and 4.

Team and individual championship among men and women in sports disciplines is performed separately.

8. Awarding

The teams, which occupy 1st, 2nd, and 3rd places, are awarded with cups and certificates; and participants – with medals and gifts.

The teams, which occupy 1st, 2nd, and 3rd places in fire relay race in and combat deployment, are awarded with cups and certificates; and participants – with medals, certificates and gifts.

The participants, who occupy 1st, 2nd, and 3rd places in individual championship in climbing on an assault ladder, overcoming 100-meter obstacle course and double-event, are awarded with medals, certificates and gifts.

Winners in sports events are awarded with champion ribbons.

The Coaches of the national teams in all the sports disciplines are awarded with medals, certificates and gifts.

9. Participation conditions of the sports delegations and participants of the competitions

The annual membership fee 3300 (three thousand three hundred) US dollars is transferred to the International Sport Federation of Firefighters and Rescuers **before April 1, 2019.**

The participation fee 210 (two hundred ten) US dollars for one member of the sports delegation is transferred to the account of the host country **before August 8**, **2019** or on the day of arrival to the competition.

The expenses, related to business trip of the sports delegations (travel tickets, accommodation, food, daily allowances during travel, salary preservation, etc.), are to be borne by the countries, sending delegation to the competitions.

The expenses, related to organization and conduction of competitions are the organizer's responsibility on account of own and involved means in accordance with the legislation.

The team which failed to pay the membership fee to ISFFR is not allowed to take part in competition (2 Regulation).

10. Procedure and timelines for submission

Preliminary application (official letter) on participation and quantitative composition of sports delegation should be sent **before July 8, 2019 year.**

Application form for participation of team in the competitions in sports disciplines must be provided to the credentials committee in the day of drawing lots September 10, 2019 year.

The standard registration form must be provided before August 8, 2019year.

This information will be used by the organizer for a meeting/departure, reservations and hotel accommodation, training of accreditation badges and other issues.
